FAMILIARISATION AND ORIENTATION PROCESS



- The Independent Directors are presented with, relevant Annual Reports, welcome letter with Company's details. The Executive Director also has one-to one discussion with the Director.

OTHER INITIATIVES TO UPDATE THE DIRECTORS ON A CONTINUING BASIS

- At various Board meetings during the year, presentations are made to the Board on financial performance, budgeting and planning, overview of performance of various businesses, statutory reporting including Internal Audit reports and compliance related certifications, overview of business of subsidiaries, risk management, company policies, changes in the regulatory environment applicable to the corporate sector and to the industry in which it operates;
